• Investment Health Check – Following our initial discussions with you, we would typically suggest carrying out an Investment Health Check. This helps to identify any potential areas of priority to focus on – whether that be ESG and mission alignment goals, strategic objectives or costs. Importantly, we can also assess whether your current investment strategy is consistent with your objectives and beliefs, and identify where we believe that there may be opportunities to make improvements or enhancements.

• Who is involved? – We believe bringing everyone into the conversation is really important, whether this be members of the Investment Committee or your wider staff. Based on our experience, effective decision making and the ultimate success of the investment strategy is much more likely when all the key stakeholders collaborate and have clear information to make decisions. We therefore advocate an open and flexible working relationship.
